Number of Links/Uploads: Each applicant is allowed five (5) links/uploads. Applicants must use at least one (1) link/upload to submit sample work. The remaining four (4) links/uploads are available to submit work samples and/or background materials.

- **Permitted Links:** Links must direct the grant reviewer to the specific sample work, or a folder with specific sample works (Google Drive, OneDrive, etc.) or an online gallery curated with sample works specifically for this grant request.
- **Links Not Permitted:** Applicants may not link directly to full sites not pertaining solely to specific sample work for this grant request. For example, do not link to a general social media account. Use the publicity section of this application to include links to social media.
- **Sample Work:** Sample works receive considerable weight in the review process and, consequently, they should be of the highest quality possible and present your strongest artistic achievements to date.
 - ♣ Grant reviewers will review a maximum of ten (10) pages of written work or fifteen (15) images or a five-minute video or audio selection.
 - ♣ Submissions over the limits described above will be viewed at grant reviewers' discretion. Please indicate which samples are your primary work samples for review in the text box provided.
 - ♣ To present multiple images, utilize one of the link boxes below to link to an online gallery (page on personal website, Flickr, Tumblr, etc.) or folder (Dropbox, Google Drive, etc.) where both images and an image link exist.
 - ♣ Materials must be accessible without a password for it to be viewed by the grant reviewers. If you require password protection, include a password in the description box below the relevant link.
 - ♣ If providing links to video or audio works (e.g., YouTube, Vimeo, SoundCloud), include instructions on where the video or audio files are to be cued to start the selection to be reviewed by grant reviewers.

 - ♣ Be sure to label all work samples properly (title of work, medium, date created, size and length) in the comment boxes provided. If work is the product of a collaboration, include a description of your role in the work's creation.
 - ♣ Links must be stable through the review period of the grant.
